Description: Demolition of covered link bridge, creation of dormer roof

extensions and alterations to existing vacant retail store (Use Class A1) with change of use to create 40 no. residential apartments (Use Class C3) at first and second floor and 4 no. retail units (Use Class A1) at ground floor together with

associated car parking. Re-submission of 18/0050.

Although Councillors expressed the view that it was good to reuse an empty building concerns remained about the lack of parking associated with the development given the problems with parking within the town. Following consideration, it was **RESOLVED** that a response be sent back to EDC SUPPORTING the application with a request that the following conditions be included if the application is approved:

- That the developers work with Eden District Council to consider ways of providing more parking associated with the development, possibly in nearby Sandgate Car Park; and
- 2. The shop fronts be in keeping with the conservation area and the market town and be of traditional design with no bright external lighting or signage.

## PL/19/82 Neighbourhood Plan

It was reported that the summary booklets and questionnaires were being posted on 4 February and that the website and social media links to the Regulation 14 consultation and documentation were live. All statutory consultees had been written to and information had been sent to community groups within the parish area offering a Q & A session at one of their meetings during the consultation period, should they feel it would be useful.

An article had appeared in the press on Saturday 2 February and there had been articles on both Eden FM and CFM radio stations. Regular press releases and social media updates would be released. The drop-in sessions had been arranged which Members were free to attend if they wished however they were reminded that they were unable to take part in any of the consultation after 15 March 2019 due to purdah in the run up to the local elections.
