FIN.COM.19/01 Apologies for Absence

Apologies for absence were received from Councillor Shepherd and Councillor Kenyon.

FIN.COM.19/02 Appointment of Vice Chairman

Members considered and voted for the appointment of the Vice Chairman of the Finance Committee.

FIN.COM.19/03 Declaration of Interests and Dispensations

Members were asked to disclose their interests in matters to be discussed and to decide requests for dispensations. None recorded.
