A grant of £895.94 has been awarded by Penrith Town Council to Riverside Group to deliver a Winter Warmth Club in the Community Café at the Eden Rural Foyer.

The Winter Warmth Club provides a safe, easy and accessible place for people living in the community, so they have somewhere to warm up, have a free hot beverage or a cup of soup, browse the internet, have a chat with somebody or charge their mobile phones at no extra cost.

The Council has also funded a Free Weekly Movie Night where visitors will be able to enjoy watching a film of their choice on a big screen in the café with a free hot beverage.

On Monday 18 December 2023, Doug Lawson, Penrith Town Council Chair and Mayor of Penrith visited the Winter Warmth Club at the Eden Rural Foyer and said:

"The Winter Warmth Club provides a vital service for local people - particularly those who are struggling financially or are suffering from social isolation.

"Sometimes people can be reluctant to access services like these, which is why having the free weekly movie night is so important - as it gives those reluctant people more of a reason to access this service.

"Supporting the Penrith community is always a priority for the Council and that is why I am delighted to see the grant funding for this much needed community project."

The Winter Warmth Club in the Community Café at the Eden Rural Foyer opened on 1 November 2023 and funding from Penrith Town Council will allow the project to run until 31 March 2024.

The Winter Warmth Club in the Community Café at the Eden Rural Foyer is running as part of "Warm Spots" - places in the community that give people a warm space to relax, work or interact with others in.

Copeland, Allerdale and Carlisle formed Cumberland Council and Eden, South Lakeland and Barrow formed Westmorland & Furness Council.

For Penrith residents (and those in the Eden Valley), this meant that all of the functions of Eden District Council and Cumbria County Council were merged and are now operated by Westmorland & Furness Council.

Explained: What is the Town Council's role in the Planning Process?

When Westmorland and Furness Council (the Local Planning Authority) receive a planning application, they must consult the Town Council as a statutory consultee. Once The Town Council receives the planning list on a Monday morning, it has 21 days in which to send a response back to Westmorland and Furness Council. The Town Council holds its Planning Committee on the first Monday of every month and publishes its agenda by the previous Tuesday. Agendas can be found at https://www.penrithtowncouncil.gov.uk/meetings/planning/

Members of the public are welcome to send us comments about planning applications within the parish area or are welcome to attend a meeting to put their views to the Committee, who will take them into account before finalising their consultation response. Because planning is quasijudicial, the Town Council must base its responses to Westmorland and Furness Council on material planning considerations.

It should be noted that any comments should also be sent to Westmorland and Furness Council who make the final decision about whether to grant an application.



January 2024's edition of Penrith Town Council News will be the first to be recorded and distributed to visually impaired Penrith locals.

Councillor Hilary Snell, Chair of the Communities Committee said:

"I am delighted to see Penrith Town Council taking further steps to increase the community's access to information enabling those with a visual impairment to access news of the councils work.

"Through this arrangement, the Council will be able to reach visually impaired people each month.

"All parts of the community should to be kept informed, and it is important that we as the Council do all we can to reach all people within our council area."

John Poland, Chair of the Eden District Talking Newspaper Association said: "It is great to see the Council making an effort to communicate with those with a visual impairment.

"The Eden District Talking Newspaper Association provide weekly readings of the news, giving around 70 recipients the independence to do things on their own they would have otherwise needed to get help for.

"However, we know there are more people out there who are blind or visually impaired who may not know about this free service.

Council approves 2024/25 Budget

At its meeting of Full Council on Monday 29 January 2024, Penrith Town Council agreed its budget for 2024/25 which includes a total expenditure of £581,932 requiring a precept of £487,735. The precept forms part of the annual Council Tax bill and is the amount of money required to fund Penrith Town Council's 2024/25 budget.

The budget includes a 1% increase in Penrith Town Council's portion of the Penrith household's Council tax bill.

The 1% increase means that the typical household in Penrith with a property valued in Band D, will see an increase of 83p per year from £83.09 per property to £83.92.

Doug Lawson, Chair of Penrith Town Council & Mayor of Penrith said:

"The 2024/25 budget reflects the Council's ambitions for a greener, healthier and more prosperous Penrith with additional budget allocated towards growth items such as tackling Climate Change, Grants for Community Groups and additional capital for the Council to develop projects for Borderlands funding - enabling the Council to potentially unlock hundreds of thousands of pounds of grant expenditure for Penrith.

"This ambition to deliver better for Penrith has meant a 1% increase for households - which follows three successive years of 0% increase.

"I look forward to working with other councillors and officers of the Council to deliver the ambition set out in the 2024/25 budget."

Charlie Shepherd, Chair of Penrith Town Council's Finance Committee said:

"As Chair of Council's Finance Committee and having worked with my councillor colleagues over recent months, I am pleased to present a budget that Council has approved."

Law and Legal Implications

The Town Council resolved from 15 May 2023, until the next relevant Annual Meeting of the Council, that having met the conditions of eligibility as defined in the Localism Act 2011 and SI 965 The Parish Councils (General Power of Competence) (Prescribed Conditions) Order 2012, to adopt the General Power of Competence.

1. Report Details

- 1.1. At its meeting of Communities Committee on Monday 9 October 2023, the Committee considered a Motion on Notice from Councillor Kenyon Creation of a 'Penrith Way' Walk and RESOLVED THAT:
 - i. Approval be given for the proposal for the Penrith Way.
 - ii. Delegated authority be given to officers to develop the scheme including designing and publicising a Penrith Way leaflet, digitalising the route, designing a Penrith Way icon to be used on signage and in the leaflet, determining locations for signage, investigating and obtaining any consents required and promoting the walk.
- iii. Costs of the development of the Penrith Way scheme are to be met from the Town Projects budget.

- 1.2. Since October's meeting, the Community Services Officer has been working closely with Councillor Kenyon to audit, alter and digitalise the route, pull together route information (such as directions) and determine appropriate locations for signage. Approximately 60 signposts are needed to facilitate the walk.
- 1.3. During the research work it was identified that it would be more effective to have a "self-led walking route" without the need for signage. The reasons for this being:
 - i. Cost a quote to print and supply circular ACM panels (150mm x 150mm) has been received at £6.95 per unit. The proposed number of signposts needed would amount to £417 with further additional costs related to consents, installation and maintenance making this aspect of the project not value for money.
 - ii. Consents some signage require consents from private individuals resulting in a more complicated consents process.
- iii. Clutter the signage would add to the clutter on columns and posts throughout the town.
- iv. Longevity the signage would not allow for future variations in the route without the removal of signs.
- 1.4. Progressing with this self-led walking route model will not materially change the wider goals of the project, with the route still being digitalised and a leaflet produced and publicised with a map of the walk (alongside directions) to promote the walk.
- 1.5. This report asks members to note the work undertaken to date and approve the revised way forward.

2. Options Analysis Including Risk Assessment

a) Risk

The Council continue with its current resolution to include physical signage as part of this walk.

b) Consequence

The negatives of installing signage as part of this walk as set out in this report.

c) Controls Required

The Council approve this revised way forward.

3. Financial and Resource Implications

3.1 As set out in the Motion on Notice from Councillor Kenyon – Creation of a 'Penrith Way' Walk, there will be costs associated with this report which include the production of route leaflets, graphic design work, digitalisation and promotion. Whilst a specific cost is not known, it is still estimated the project may cost in the region of £1000 - £1500.

The Town Council resolved from 15 May 2023, until the next relevant Annual Meeting of the Council, that having met the conditions of eligibility as defined in the Localism Act 2011 and SI 965 The Parish Councils (General Power of Competence) (Prescribed Conditions) Order 2012, to adopt the General Power of Competence.

1. Report Details

- 1.1. The Council are continually seeking to increase the community's access to information and improve transparency and accountability.
- 1.2. Recognising the importance of print media as a mechanism for communicating Council information with those hard-to-reach areas of the community who get their information through printed mediums- and solely through those mediums, in October 2023, the Communities Committee resolved to provide the Cumberland & Westmorland Herald with a quarterly advertisement of Council news.
- 1.3. It is proposed that the Council expand its reach in print media through advertising council information through another printed media outlet.
- 1.4. The Council could look to diversify its reach through advertising its information in a free to access publication.
- 1.5. Cumbrian Local Publications produces a monthly newsletter: Eden Local.
- 1.6. The Eden Local is distributed to all households in Penrith free of charge with each edition also free to read online.
- 1.7. The Council has previously regularly advertised its information through this publication, in an informal arrangement. This report proposes a more formalised arrangement.

- 1.8. It is proposed that the Council produce a quarterly advertisement in the Eden Local.
- 1.9. An insert in the Eden Local would be provided on the following terms:
 - i. An advertisement would be provided to the Eden Local on a quarterly basis (Winter, Spring, Summer & Autumn) starting from May 2024.
- ii. The size of the advertisement would vary according to content available.
- iii. The advertisement would consist of Penrith Town Council News.
- iv. Penrith Town Council would have control on the content provided.
- 1.10. Content provided for the Eden Local would be replicated on Penrith Town Council's digital channels, ensuring equality of access to Council information.
- 1.11. Content deadlines for proposed editions are specified below:

- 1.12. Further editions will be booked on a quarterly basis (Winter, Spring, Summer & Autumn) according to the schedule at the time.
- 1.13. This arrangement would be reviewed on an annual basis by the Communities Committee.

2. Options Analysis Including Risk Assessment

a) Risk

Penrith Town Council does not communicate with those hard-to-reach groups who get their information through (free) printed mediums and solely through those mediums.

b) Consequence

Those individuals are excluded from Penrith Town Council communication.

c) Controls Required

To advertise in a (free) printed publication which is provided to each household in Penrith.

3. Financial and Resource Implications

- 3.1 Cost for including full page: £280 £340 (left right).
- 3.2 There will be a staffing implication for the Council's staff to provide the content needed in each edition, but it is considered that the time and workload is manageable within existing resources.
