3. Conserve and enhance local biodiversity

- Ensure the protection of green spaces and natural habitats in the possession of Penrith Town Council and as set out in the Neighbourhood Plan
- · Have the Council adopt a Biodiversity Policy and Action Plan at a meeting of Full Council

4. Promote low emission transportation options

- Lobby for incentives for the use of electric vehicles
- · Work in partnership with organisations and write to central government to lobby for incentives
- Work in partnership with appropriate organisations to investigate the increase the electric vehicle charging infrastructure
- Develop a policy and action plan for supporting sustainable and community transport schemes


Musgrave Monument repair work

The Musgrave Monument has had a piece of stone masonry repaired following a member of the public climbing onto the monument and dislodging a large piece of decorative stone.

Askins & Little, Stone masonry specialists, were contracted to carry out the work – with the monument now being restored back to its former glory!

Fairhill Slide fixed

The slide at the Fairhill Play Area has been repaired following one of the Council's routine inspections identifying a bolt which had been unscrewed and removed from the base of the slide.







Damaged Tree felled at Fairhill

Following Storm Isha, one of the mature pine trees at Fairhill Playing Field was damaged.

The Council commissioned Lowther Forestry to inspect the tree who reported that a dominant limb was torn off resulting in a large stem wound close to where the remaining two limbs are attached. It was reported that the remaining limbs may weaken over time. A pedestrian desire line passes under these two limbs and as such the tree has now been felled. The Council may seek to replace the tree later on in the year.

Purpose of Report:

To provide an update on the arrangements for the D-Day Commemoration Event on Thursday 6 June 2024.

Recommendations:

To note the arrangements made to commemorate the 80th anniversary of D-Day.

Law and Legal Implications

The Town Council resolved from 15 May 2023, until the next relevant Annual Meeting of the Council, that having met the conditions of eligibility as defined in the Localism Act 2011 and SI 965 The Parish Councils (General Power of Competence) (Prescribed Conditions) Order 2012, to adopt the General Power of Competence.

1. Report Details

- 1.1 In 2018, the Town Council marked the commemoration for the 100 year anniversary for the end of World War I (WWI).
- 1.2 This year, the Pageantmaster, Bruno Peek, has invited Town and Parish Councils as well as other organisations to mark the 80th anniversary of the D-Day operation by lighting a beacon on 6th June 2024 in celebration of the 'light of peace' that emerged out of the darkness of war. It is an opportunity to remember over 209,000 Allied casualties of the operation.
- 1.3 At its meeting on 9 October 2023, the Communities Committee resolved to take part in the 80th Anniversary D-Day Commemorations to be held on 6 June 2024 with delegated authority being given to officers to progress the event.
- 1.4 The primary, secondary and independent schools in Penrith have been sent a letter and the poem inviting them to get involved by reading out the poem in school at the required time.
- 1.5 National Fish and Chip Day is now in its 9^{th} year and in order to mark D-Day 80, will be celebrating on 6^{th} June because of the strong links fish and chips had with WWII. Letters have also been sent to the fish and chip shops inviting them to be involved during the day in line with the information published by the Pageantmaster.
- 1.6 The BIDs and Chamber of Trade have been contacted to circulate information to the businesses asking them to put a light of peace in their premises and residents will also be encouraged to do the same via press releases and our social media accounts.

- 1.7 The PCC have given permission to hold the lighting of the beacon in St Andrew's Churchyard and a risk assessment has been prepared, based on the previous beacon lighting, and sent to the PCC for information.
- 1.8 This was felt to be the best location based on the number of people who attended the lighting for the Late Queen's Jubilee.
- 1.9 Before the lighting of the beacon at 9.15pm in St Andrew's Churchyard, Committed2Rock will be performing some period songs. They will pause whilst the beacon is lit and the International Tribute recited before performing one more song afterwards.
- 1.10 Councillors are asked to provide some marshalling support in the evening as we expect there may be a large crowd based on our previous experience.

2. Options Analysis including risk assessment

a) Risk

Reputational risk of the Council by not participating in the national event.

b) Consequence

The reputation of the Council would be damaged.

c) Controls Required

Participate in the D-Day commemoration event as proposed.

3. Financial and Resource Implications

There are resource implications in officer time and the cost of approximately £250 to facilitate the event which can be met from the Town Projects budget.

4. Equalities Implications

None. The events is easily accessible and free to attend.

Law and Legal Implications

The Town Council resolved from 15 May 2023, until the next relevant Annual Meeting of the Council, that having met the conditions of eligibility as defined in the Localism Act 2011 and SI 965 The Parish Councils (General Power of Competence) (Prescribed Conditions) Order 2012, to adopt the General Power of Competence.

1. Report Details

- 1.1. Penrith Town Council (the Council) currently owns and maintains the town centre noticeboard on Angel Lane.
- 1.2. The noticeboard is used to publicise the Council's meeting agendas, hard copy newsletters and is open to community groups to promote their events / activities.
- 1.3. There are a number of other noticeboards servicing other areas in Penrith such as Pategill and Castletown.
- 1.4. To increase the community's access to information and improve transparency and accountability, it is suggested that the Council purchase and install another noticeboard to service another area of Penrith in which there is currently no noticeboard.
- 1.5. Fairhill Playing Field, owned by the Council is considered the most appropriate location for a noticeboard.
- 1.6. The field has hundreds of visitors a day accessing the grounds of the field for recreational purposes or accessing the popular Fairhill Play Area meaning the information provided on the noticeboard would likely be seen by hundreds of people a day.
- 1.7. The field is also in the ownership of the Council, negating the need to seek consent for installation of the noticeboard, making the process quick and simple should the committee be supportive of this proposal.
- 1.8. These factors therefore make Fairhill Playing Field an ideal location for the Council to install another noticeboard.

- 1.9. A site plan marking the proposed location for the noticeboard can be viewed at Appendix A.
- 1.10. The noticeboard is proposed to be situated next to the gate at the entrance to Fairhill Playing Field from Salkeld Road ensuring everybody who enters Fairhill Playing Field from Salkeld Road or passersby's on Salkeld Road are able to see the noticeboard.
- 1.11. The noticeboard proposed as part of this report would be similar to the current noticeboard on Angel Lane, however, would be free standing.
- 1.12. The noticeboard would be installed at the proposed location by the Council's community caretaker.

2. Options Analysis Including Risk Assessment

a) Risk

Council information is not as accessible to members of the Penrith community.

Consequence

A lack of engagement with the Council.

b) Controls Required

The Council install a noticeboard at Fairhill Playing Field.

3. Financial and Resource Implications

3.1 The cost for the purchase of the noticeboard is £1,100 plus VAT. There will also be a cost associated with installation of the noticeboard which will be met from the Council's communications budget.

Recommendations:

i. Penrith Town Council renew its contract with Granicus for the govDelivery service for April 2024 – April 2025.

Law and Legal Implications

The Town Council resolved from 15 May 2023, until the next relevant Annual Meeting of the Council, that having met the conditions of eligibility as defined in the Localism Act 2011 and SI 965 The Parish Councils (General Power of Competence) (Prescribed Conditions) Order 2012, to adopt the General Power of Competence.

1. Report Details

- 1.1. In April 2023, Penrith Town Council commissioned govDelivery, an email distribution platform, on a one-year contract to increase the community's access to information and improve transparency and accountability.
- 1.2. govDelivery is used by the Council to build and design branded e-newsletters (emails) on Council business, updates and more to subscribed audiences, with subscription being free for users.
- 1.3. The govDelivery system has expanded the Council's reach and transformed its communication, providing the Council with a means of direct communication with the Penrith public.
- 1.4. The system is due for renewal in April 2024 and with the Council's Communities Committee being responsible for the delivery of Council Communications, this report asks the committee to consider the renewal of the system for another year.
- 1.5. The Council currently uses govDelivery to send e-newsletters to five different mailing lists: Climate Change & Green Spaces (to be launched alongside the renewed Climate Strategy), Council Meetings, Events & Activities (in and around Penrith), Latest News and Members Updates.
- 1.6. Since the launch of the system on 28 June 2023, the Penrith Town Council govDelivery account has amassed 1,393 topic subscriptions, sent 6984 e-newsletters, had average total open rates of 72.8%, average click rates of 15% and an average engagement rate of 88.7%.

- 1.7. The Council also publicise the links to all of its e-newsletters through the Council website and social media pages. Factoring this in, the Council's open rates rise to approximately 116%.
- 1.8. Average open rates for Government organisations are $\underline{19.4\%}$, with click rates averaging at $\underline{2.8\%}$. The performance of the Penrith Town Council govDelivery account is therefore well above that industry standard.
- 1.9. The Penrith Town Council govDelivery account has also seen organic growth since launch with very little associated promotional costs. The account has averaged a gain of approximately 116 topic subscriptions per month, with the numbers of subscribers increasing daily.
- 1.10. The performance of the account demonstrates a desire from the Penrith public to continue to be kept informed through this direct means of email communication.
- 1.11. It is therefore proposed to continue using an email distribution platform for Council communication to enhance and build upon its other existing communication channels.
- 1.12. During this renewal period, other email distribution platforms have been considered alongside govDelivery including Campaigner and Campaign Monitor.
- 1.13. Costs for similar packages to the current contract the Council has for the govDelivery product with these email distribution platforms are outlined as follows: Campaign Monitor £4,428 per annum, Campaigner £5,628 per annum. The govDelivery package is £4,815 per annum.
- 1.14. It is recommended that the Council renew its contract with Granicus for the govDelivery service for April 2024 April 2025 for the reasons set out below.

Reasons for renewal with govDelivery

- 1.15. The Council has an established, engaged subscriber-base with govDelivery. If an alternative email distribution platform was chosen, the consent of each individual subscriber would be needed to transfer their email contacts onto an alternative system likely resulting in the loss of hundreds of subscribers.
- 1.16. More than 1,800 public sector organisations use govDelivery worldwide, including over 400 in the UK such as the ONS, Cumbria Constabulary, Cumberland Council and Westmorland and Furness Council making it the number one public sector communications platform.
- 1.17. govDelivery operates an Information Security Management System which complies with the requirements of ISO/IEC 27001:2013, meets G-Cloud assurance requirements, is Cyber Essentials certified and is fully GDPR compliant. This gives the Council the confidence that subscriber information and all communications through the system are fully GDPR compliant.
- 1.18. The "govDelivery Network" enables cross promotion of the Council's govDelivery system as it's linked to Cumberland Council, Westmorland & Furness Council and Cumbria Constabulary, meaning once users have subscribed to those organisations, they will then be offered the opportunity to subscribe to Penrith Town Council.
- 1.19. The govDelivery Network has so far yielded around 55% of the Council's govDelivery subscribership, subscribers the Council would not have gained through another system.
- 1.20. govDelivery achieve inbox delivery rates in excess of 98%, significantly above the industry average of 84.2%, reducing the number of emails sent to a spam or junk folder.

- 1.21. The govDelivery "Questions" feature allows the Council to collect data from subscribers when they sign up for updates. For instance, the Council could ask each subscriber which ward of Penrith they live in and personalise email updates for specific wards in Penrith. The feature could also be expanded to cater to interests, demographics and more.
- 1.22. govDelivery place no limit on the number of emails which can be sent through the system or the size of the email – enabling the Council to control how much content it puts out there and how often.
- 1.23. govDelivery place no limit on the number of administrators, enabling the system to grow with the Council.
- 1.24. govDelivery is used by the Council as an image and file repository, enabling the Council to upload images and files making those easily accessible to the public through links.

2. Options Analysis Including Risk Assessment

a) Risk

The Council does not commission govDelivery and does not communicate with an established base of engaged subscribers.

Consequence

Those individuals are disenfranchised from Penrith Town Council information.

b) Controls Required

Penrith Town Council renew its contract with Granicus for the govDelivery service for April 2024 – April 2025.

3. Financial and Resource Implications

- 3.1 Cost £4,815 per annum (April 2024 April 2025).
- 3.2 Council (Jan 24) approved the budget for 2024/25 and the costs of this service will be within the approved budget.
