b) Reports from Westmorland and Furness Councillors

Members received the following reports:

Cllr Bell informed the meeting that:

The "Scaws Recreation Group" had been formed – who are a new group of residents focusing on ways of improving open recreation areas in Scaws. The group is open to all Penrith residents.

Options are being explored for additional sites in Penrith to be used for parking.

Designs are being looked at for the double roundabout at the bottom of Fell Lane, subject to funding.

The toucan crossing at Pennyhill Park is soon to be installed. Once this is installed, the Speed Indicator Device will be reinstalled.

Westmorland & Furness Council Officers are looking into how to assist residents with road crossing at Tara Hill.

Additional signage has been agreed to be installed at Friargate car park.

Westmorland & Furness Council is to be conducting a review of residents parking in early 2025.

Westmorland & Furness Council has begun its first conversation on future Waste & Recycling services in the Westmorland & Furness Council area.

Residents of Bowscar have asked for a green waste skip and street lighting.

She is awaiting news of whether the money set aside by Westmorland & Furness Council, is sufficient to confirm a town bus provider.

Cllr Eyles informed the meeting that he had received concerns from a resident about the provision of disabled parking in Penrith.

e. Local Government Services Pay Agreement 2024-25

Members noted that the National Association of Local Councils (NALC) had informed member Councils of the new rates of pay applicable from 01 April 2024. With effect from the 01 April 2024 an increase of £1,290 (pro rata for part-time employees) would be paid as a permanent addition on all NJC pay points 2 to 43 inclusive, and an increase of 2.5% would be applied to all pay points above pay point 43. The new rates of pay and backdated increases would be paid to Council staff at the end of November. The 2024-25 approved budget provides fully for the new rates of pay.

PTC24/68 May Day Event 2025

Members received an update on the progress to date for the organisation of the May Day event and considered whether to explore quotations and to appoint an experienced Cumbrian based events management contractor to oversee the delivery of the May Day event.

PTC24/70 Consultation, continued

- i. **Virtual Meetings**: recommends that each council should be able to determine its own policy as to how and if it enables remote attendance at meetings. That there should be consideration within the policy and legislation for:
 - a) How confidentiality is maintained.
 - b) How the notice of agenda may be affected if a public meeting becomes a virtual meeting at short notice.
 - c) If agreed and legislated for that revised standing orders guidance is issued.
 - d) Hybrid arrangements.
- ii. **Proxy Voting**: Penrith Town Council does not support proposals to introduce proxy voting for local authority meetings. It is considered that an open debate is an essential part of effective decision making and local representative democracy and the introduction of proxy voting would erase this.
